Young People's Health Passport

Iceni Healthcare, in partnership with Cambridgeshire Community Services, is creating a Young People's Health Passport - a mobile phone app that provides useful information to support young people's health and also gives them access to their personal medical history.

It covers topics including travel, festival safety, drug and alcohol advice and information on how to cope with depression, bullying and eating disorders. It will signpost young people to organisations that can offer further support and it gives them access to their own health records including their immunisation history, repeat medication and diagnosed conditions.

In July we carried out a survey at the Royal Norfolk Show, asking young people to test out elements of the design on

tablet devices. The response we received was extremely positive.

We spoke to 132 young people and discovered that the 15-18 age group was most likely to use the app, with 86% saying the information was useful. They found the app easy to navigate and gave lots of useful feedback on the look of the app and suggestions for additional features. For instance, 87% said they would use ChatHealth, the confidential school nursing team text messaging service, if it was available within the app.

A detailed service specification has now been created and further development of the app's story board will be presented to a focus group at Norwich City College in November.

Block Contracts and Bulk Discounts Occupational Health Discount for Members

Following NHS England's decision to cease central funding in Primary Care for occupational health services, we have negotiated a 10% discount for all Iceni Healthcare member practices with University Medical Services (UMS) at the University of East Anglia.

There is no upfront payment for using the UMS service, and no contract to be signed. This means, if you wish to use UMS Occupational Health for services such

as pre-employment screening, you remain free to refer members of staff to a provider closer to your location for other requirements.

E-Learning

Sixty practices have now signed up to use Skills for Heath for their staff training needs after Iceni Healthcare secured a significant discount on the subscription fees.

Practices have saved an average of 60% on training costs with Skills for Health, which is now entering the third year of a five year contract.

Iceni Healthcare also secured an average 50% discount with another provider - Blue Stream Academy - to give member practices a wider variety of training resources. There are currently 13 practices signed up to Blue Stream Academy.

Commercial Waste

Iceni Healthcare has negotiated a number of bulk discounts with waste disposal companies after NHS England decided to stop reimbursing practices for trade waste costs.

We have agreed discounts of at least 25% with Avena Environmental, Restore Datashred and Shred-it, who all remove commercial and confidential waste, and with Veolia for general waste disposal and recycling.

These providers have agreed to pass on the Iceni Healthcare negotiated discounts on cessation of current contracts.

Positive Response to the Healthy Child Programme - But We Need Your Help

It is two years since Iceni Healthcare began providing elements of Norfolk's 0-19 Healthy Child Programme in partnership with Cambridgeshire Community Services NHS Trust (CCS). The results so far are very positive – but we need your help to ensure its success, and our future.


Iceni Healthcare is delivering three significant workstreams to the contract with Public Health:

- an all-new School Readiness Check for pre-school children, developed with CCS health professionals and delivered in practices during existing child immunisation appointments
- an innovative School Profiling system which generates health 'footprints' of school populations using anonymised data extracted from GP and community health records such as incidence of allergies and certain health conditions. The results will help prioritise health education topics for teaching and support health service provision in school
- a new Needs Profiling process to help identify children, young people and their families who may have additional health needs and put in place tailored preventative and early intervention packages of care.

The response to the School Readiness Check has been very encouraging. 96% of parents/carers say they are likely to recommend it to friends and family. Nearly a quarter (22%) said they would do something different as a result such as look at healthier eating options, make a dental appointment for their child or spend more time reading with them to improve their conversation.


Currently 86% of practices are signed up to the School Readiness Check and 140+ nurses have received training to deliver the service. However, only 57% of practices are supporting Iceni Healthcare's Data Warehouse which generates the data for School Profiling and Needs Profiling,

We need universal sign up by practices to both the School Readiness Check and Data Warehouse in order to meet our KPIs, guarantee the success of this contract and safeguard the


Financial Statement

The year to 31 March 2017 was another successful one for the company, the net profit before taxation amounting to £40,991.

Income from the company's principal activities in the year – the Healthy Child Programme (HCP) and the Apprenticeships initiative - aggregated to £745,870, out of total income for the year (excluding interest received) of £768,316.

Last year was the first full year of the HCP. Our funding from Cambridgeshire Community Services included an element for the Needs Profiling and Schools Profiling components of the contract, neither of which had been completed by the year end. Accordingly part of the monies received has been deferred into the current financial year.





The profit before taxation amounted to £40,991. Although no corporation tax is payable by the company by virtue of tax losses brought forward, the tax charge in the Income Statement reflects the reduction in the deferred tax asset.

The Statement of Financial Position shows that the net asset position of the company has improved during the year, to £179,653 at the year end. The substantial balances held in the company's bank accounts reflect the receipt of funds in advance of the relevant work being performed; the cash balances will reduce in the current year as the HCP operates at full level.

The company remains in a sound financial position, providing a secure base from which to explore opportunities to develop new income streams for our member practices in the current and future years.
